I am honored to announce our new partnership with the National Tribal Emergency Management Council and the National Joint Powers Alliance. This has been an amazing year for the NWTEMC, an organization that was formed for the purpose of promoting Emergency Management and Homeland Security in Indian Country. I am humbled by the amazing progress that this Council has made since its inception in 2004.

When our great Nation was attacked on September 11, 2001, the history of our Nation was re-written and the way that we addressed the security of the homeland was changed forever. As we looked closer at our country and what is known as critical infrastructure, we learned that a great deal of our most essential and vulnerable resources were located on Tribal lands, to include, but not be limited to our International Borders, our International Shipping Lanes, our Oil Refineries, our Military Bases, our Pipelines and our largest Power Dams. And, yet, the Tribes were not a part of the National Conversation on how to better protect our Nation.

Eight Tribes in Washington State first met in 2004, with the idea of forming the Northwest Tribal Emergency Management Council, to help promote emergency management and homeland security in Indian Country. The "Northwest" in NWTEMC was chosen to represent those Tribal Nations of WA State Homeland Security Region I. Since its inception, the "NW" has grown to mean more than those original eight Tribes, but now, the greater Pacific Northwest Region of the United States. The membership today represents more than one hundred thirty Tribal Nations throughout the four State area of Washington, Idaho, Oregon and Alaska.

On January 29th, 2013, the President of the United States signed The Hurricane Sandy Relief Bill. For the first time in US history, our Tribal Nations were granted the ability to declare disaster declarations in Indian Country and request financial assistance for recovery directly to the President.

In this past year alone, our Country has experienced hurricanes, explosions, ice, snow, windstorms and tornados like never before in our entire history. We have seen earthquakes on the west coast, flooding throughout the mid-west, fires across the nation and have evacuated entire communities to keep our people safe. With the increase in events across our Nation, the NWTEMC saw a critical need to reach out across the nation to share the great work being done in the Pacific Northwest by helping to create the National Tribal Emergency Management Council.

Our Tribal Nations have come together to promote the true meaning of sovereignty: self-determination, self-reliance and self-governance. In some token, we recognize that in a true National Disaster, we must be able to come together, to work together, and to respect one another as we plan, prepare, respond and recover. Our Tribal Nations have strengthened relationships with our Local, State and Federal Partners. Today, we look to forge greater relationships with NJPA and Corporate America as the newest and greatest additions to this family. The NWTEMC is also proud to partner with the National Tribal Emergency Management Council into 2014. It is in these partnerships that we have proven what emergency management and homeland security is truly all about. Our goal for the coming year is to continue to grow, learn and share best practices throughout our great Nation. Happy 10th Anniversary NWTEMC and Congratulations to the National Tribal Emergency Management Council. May we share many more years together.

Biographies

Northwest and National Tribal Emergency Management Board and Staff

Claude L. Cox (Spokane Tribe)

Claude Cox has served as the Chairman of the Northwest Tribal Emergency Management Council (NWTEMC) since 2008, a consortium of more than 140 Tribal Nations throughout Washington, Idaho, Oregon and Alaska. Mr. Cox is also serving as the interim Chairman of the National Tribal Emergency Management Council (NTEMC). Mr. Cox is the Chief of Police for the Sauk-Suiattle Tribe. He previously served as the Chairman of the Spokane Tribal Enterprise Corporation and the Tasha Director for the Spokane Tribe. Claude has been responsible for law enforcement, emergency management, risk management, benefits management, safety lost control, and corporate operations. Prior to his current role, he had served as a Disaster Assistance Employee to the Federal Emergency Management Agency (FEMA), and was President of the Washington Counties Risk Pool and Risk Manager for the Spokane County Safety Department. Claude Cox is a proud enrolled member of the Spokane Tribe.

Del Ostenberg

Del Ostenberg currently serves as the Vice Chairman of the NWTEMC-NTEMC. He is also the Risk Management Safety and Compliance Officer/Emergency Manager for the Confederated Tribes of the Colville Indian Reservation. Del worked for the Department of the Interior, Bureau of Indian Affairs for 34 years. During that time Del worked in Fire Control, Forestry and Fire Management. The last 16 years have been in Fire Management as a Training Officer. Del is a Fire Management Training Officer, training and assisting instruction of ICS thru 400 levels (National Multi-Agency Coordination Group), Fire Investigation and various safety classes. Del was part of the team that developed the National Incident Qualification System computer program for all risk at the National Interagency Fire Center. Del is qualified in the following wild land fire positions: Fire Fighter, Crew boss, Dozer boss, Engine Boss, Strike Team dozer-engine-crew, Task Force Leader, Division Group Supervisor, Incident Commander (Type 3, 4, 5,), Fire Investigator type I, II and III, Safety Officer Type II,III,IV and V. Del has worked with several Prevention and Type I and II IMTs, both on and off the reservation, from Alaska to Florida. Del is also an EMT, part of the CISM Debriefing team, and member of the Search & Rescue team 35 years. Del has been a part of the Safety Committee, Chairman for the Mount Tolman Complex Safety committee and Chairman for CCT Safety Committee. Del helped to develop the CEMP for the Colville Indian Reservation, as well as several associated EM plans.

Kevin Lenon

Kevin Lenon currently serves as the Secretary of the NWTEMC-NTEMC. Kevin is currently the Vice Chairman of the Sauk-Suiattle Tribe. He is also a lifelong Native American Carver, carving Native American articles, canoes, and work to restore Tribal Cemeteries and grave sites. He is also currently a professional river guide. Kevin also works for the Sauk-Suiattle Natural Resources Department, assisting with preservation and restoration projects. Kevin Lenon volunteers for Fire District #24 of Darrington as a Fire Fighter and Water Rescue Team Member.

Jim Sande

Jim Sande currently serves as the Treasurer of the NWTEMC. Jim Sande has established a career with the Swinomish Tribe for the past 17 years. He is currently the Emergency Manager for the Tribe. His prior experience includes 14 years as a police officer and sergeant with the Swinomish Police Department. Jim is credentialed as a CEM by IAEM. He holds an ABCP certification with DRI International. His experience includes: ICS and CERT instruction; major disaster declaration recovery efforts; grants management; comprehensive emergency management planning; and NIMS implementation. Jim is a firm believer in leveraging partnerships and developing relationships among emergency management partners.

Steven M. Golubic

Mr. Steve Golubic currently serves as the Executive Director of the National Tribal Emergency Management Council. Steve recently retired as the first Director of Tribal Affairs in the Intergovernmental Affairs Office of the U.S. Department of Homeland Security (DHS). In that position, he oversaw the department wide DHS Tribal Consultation Policy and ensured all component agencies within DHS were fulfilling their responsibilities toward tribal consultation. He advised the DHS Secretary's Office on tribal issues for establishing, maintaining, and coordinating a nation-to-nation, federal-tribal relationship. Mr. Golubic also previously served as the National Tribal Liaison, at the Federal Emergency Management Agency (FEMA) Headquarters, in Washington, DC. In that position he served as a liaison, on behalf of the Agency, with tribes, state and local officials. He was the primary advisor to the FEMA Administrator on outreach activities related to tribal officials, tribal organizations, and tribal associations. He participated in special projects to develop, recommend, and implement proactive long and short term strategies for tribal activities related to the Agency's mission, program policies and initiatives. He is an adjunct instructor at the Emergency Management Institute in Emmitsburg, Maryland teaching the tribal specific curriculum. Mr. Golubic also served in field positions for the Agency, during presidentially declared disasters, to ensure that tribes and their communities expeditiously received Federal disaster assistance to help them rebuild their lives and their communities. Before joining FEMA, Mr. Golubic spent more than two years as the Homeland Security Director at Great Lakes Inter-Tribal Council in Lac du Flambeau, Wisconsin. His career also includes nearly 20 years as a county emergency management director, safety consultant with Wausau Insurance, Director of the Wisconsin Council of Safety and Executive Director of Wisconsin Operation Lifesaver. Mr. Golubic also served on the Board of Directors for the Wisconsin Emergency Management Association (WEMA) as a regional representative and also as president.

Lynda Zambrano

Lynda Zambrano currently serves as the Executive Director of the NWTEMC and Deputy Director of the National Tribal Emergency Management Council. Lynda began her career in law enforcement 20 years ago, working with Federal, State, Local and Tribal governments. Lynda has also served as Health Director for several Tribal Nations, which has given her a unique perspective to bring together many different disciplines to work together in emergency management. Lynda has an extensive background in finance, contracts management and audit compliance work. Lynda is a grants writer, assisting with securing more than one hundred grants and several million dollars for Tribal Nations in the State of Washington. Lynda has received recognition for her work in Indian Country from the Federal Emergency Management Association, US Department of Homeland Security and US Bureau of Indian Affairs. Most recently, Lynda was inducted into the International Association of Women in Emergency Management's Hall of Fame. Lynda is the proud wife of Richard Zambrano, whom is a member of the Snoqualmie Tribe, and mother of three.

Lillian Sparks J.D.

Presidentially appointed, Lillian A. Sparks was confirmed by the United States Senate as the Commissioner of the ANA in March 2010. A member of the Rosebud and Oglala Sioux Tribes, Ms. Sparks has devoted her career to supporting the educational pursuits of Native American students, protecting the rights of indigenous people, and empowering tribal communities. Prior to her appointment, Ms. Sparks served as the Executive Director of the NIEA where she worked extensively on K-12 and early childhood education policy to secure funding to positively impact American Indian, Alaska Native, and Native Hawaiian students. With a background in Political Science and Law, Ms. Sparks was named one of seven young Native American Leaders by USA Today Magazine.

Cynthia Iyall

Cynthia is currently serving her third consecutive term as Chairwoman and previously served a term on the Council in the Fifth Councilmen in 1997. She has also served as the WIGA Treasurer for 7 years. She has a Bachelor's Degree in E-Commerce from City University and an Associate's Degree in Entrepreneurship from Northwest Indian College where she graduated with Honors. She is a graduate of Tumwater High School. Previous to her Council work, Chairwoman Iyall was the Economic Development Planner for the tribe since 1996. Cynthia enjoys participating and attending cultural events, learning Native songs and dances as well as Native language. She believes in Sovereignty and works toward building the strength, health and wealth of Nisqually in order to be a healthy and self-sufficient community.

James Roddey, Featured Lunch Speaker

James Roddey is an award winning author, director, and natural hazards expert who has worked as the Earth Sciences Information Officer for the state of Oregon and the Director of Communications for the American Red Cross. Roddey also led the first of its kind, federally funded, tsunami readiness outreach and education program in the nation, working with over two dozen cities at the Oregon coast over the course of two years. Roddey is a familiar face to people around the country when natural disasters strike, through his appearances nationally on The O'Reilly Factor, CNN, The CBS Evening News, and NPR. With a background in broadcasting, marketing and geoscience education, Roddey's empowering message to national conference audiences and town hall gatherings is to prepare for the unexpected and create partnerships.

I have over 7 years of Law Enforcement experience with the Quinault Indian Nation Police department and Bristol Bay Burrow Alaska police department. I attended the Federal Law Enforcement Training Center Basic Police Academy in Artesia, New Mexico, the DEA Clandestine Lab School in Quantico Virginia, I have attended the Washington State Field Training Office School and the FEMA basic Emergency Management Academy.

Joan Smeltzer

Joan Smeltzer is a Tribal elder of the Snoqualmie Tribe. Joan is a graduate of the Community Emergency Response Team training at the Colville Nation (July 2012) and has spent the last few years better preparing her family and her community for any type of major event. Joan likes to can traditional foods and preserve dry goods. Last year, Joan and her grandchildren, also graduates of the CERT class, were activated by the local county emergency management department to assist following the devastating windstorm of Ferry County that destroyed 40 miles of power poles and left large areas of the county and the Colville reservation without power for several days.

C.M. Sam Jenkins

C.M. Sam Jenkins spent 30 years in the US Air Force, the last ten of which were as the Non-Commissioned Officer in Charge of the 446th Wing Safety Office at McChord AFB. He developed a new safety evaluation program that won the unit the Air Force Reserve Command safety office award of the year in 2005. He was a National Coordinator and Safety committeeman for Home Builders Institute, writing the company safety handbook and a corporate trainer. After retiring, Sam saw the need for public disaster education in the local community and, with the support of the local officials, registered a Citizen Corps Council. He joined the Search and Rescue team and currently serves as its President. And beginning October 1, 2012 he will also be coordinating the installation of three large generators to enhance the community preparedness and response capability in three towns on the Nez Perce Reservation (THSGP 2012). All three programs are courtesy of the Department of Homeland Security, Tribal Homeland Security Grant Program (THSGP).

Ken Choke

Born and raised in the Pacific Northwest, Ken Choke is an Enrolled Member of the Nisqually Tribe and has lived there some 20 plus years. Ken began his career in Emergency Management as a Law Enforcement Officer (Fish and Wildlife) and established the Department 2 plus years ago through the request of the Chief of Police, Tribal Council and General Council. The first major incident Ken was involved with was the Nisqually Earthquake while working for the Fish Hatchery. Since then Ken has dealt with several incidents to include a major wind storm that caused debris on the roadway and knocked out the power to the reservation. Ken was responsible for helping to develop a CERT team to assist in major events and with the wind storm, the CERT helped remove the debris so that Power could be restored to the Reservation and the surrounding areas. Ken helped develop the plans for the Youth/Emergency Center in the event of an Emergency as well the Tribes Emergency plans. The first activation of the Youth/Emergency Center was the MLK winter storm of 2012 which provided services for the Tribal Community and the surrounding areas as well assisted the American Red Cross with their requests for food for local shelters. With the help of the Emergency Management Team, Ken implemented the ICS structure to assist the Tribe with its first co-host of the Tribal Canoe Journey 2012 Paddle to Squaxin. Ken is currently the Tribe's liaison for membership in the NWTEMC and the Washington State Lead for the National Tribal Emergency Management Council.

As a Special Weapons and Tactics Operator with the FBI in San Francisco and Oklahoma City Divisions, he responded to incidents which included the Los Angeles Rodney King Riots, the Branch Davidian standoff at Waco and the bombing of the A.P. Murrah Building in Oklahoma City. Walter founded and supervised the Oklahoma City Violent Crimes Task Force, was a member of the FBI Speakers Bureau, an FBI Special Agenda Recruiter, an FBI spokesperson and a member of the FBI Director's Native American Board of Advisors. He appeared on the America's Most Wanted and Unsolved Mysteries television programs and is prominently featured in John Walsh's book entitled, No Mercy. Walter was twice awarded the FBI Shield of Bravery, and is one of only two agents in the history of the FBI to receive the prestigious medal. His parents are the late Newton Lamar (Wichita), a nationally recognized tribal leader, and Catherine Gobert Lamar (Blackfeet), a retired Bureau of Indian Affairs department head. Walter is married to Dr. Cynthia Chavez Lamar (San Felipe Pueblo, Hopi, Navajo and Tewa), Director of the Indian Arts and Research Center at the School for Advanced Research, Santa Fe, NM.

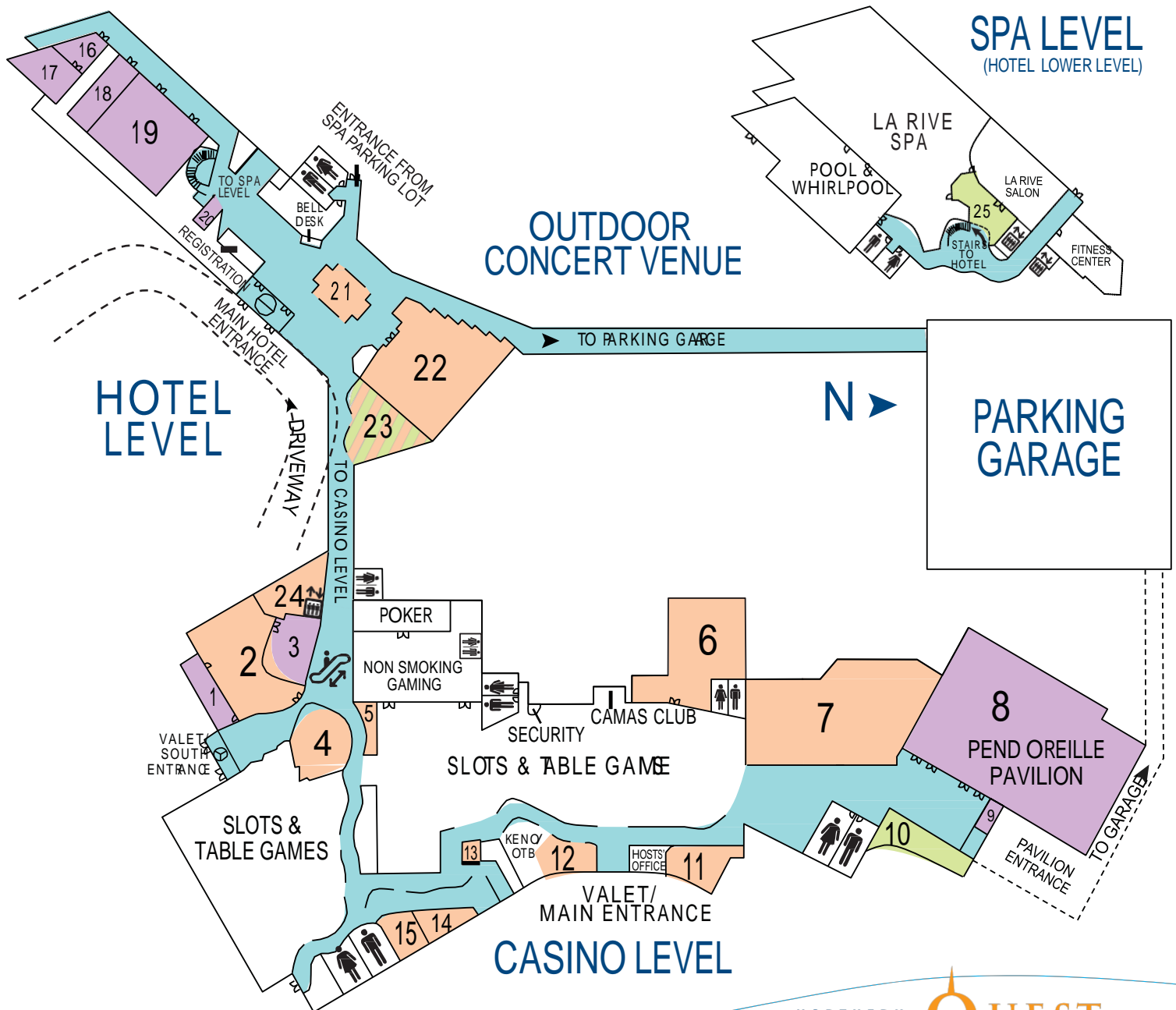
Course topics will include:
